Chapter 251

LICENSING UNDER PARTS II, III, AND IV

In accordance with Section 175 of the Insurance Act, Chapter 251, Laws of Belize, RE 2020, the General Public is hereby notified that **only the following persons have been provided with an Insurance Licence to carry on insurance business in Belize during the year 2023.** All licensees mentioned herein have been provided with an **Insurance License Certificate.** In addition to the licence certificate, individual insurance intermediaries were issued an Insurance Intermediary Card, which must be produced upon simple demand by any member of the public.

Only Licence Certificates for the Year 2023 are valid.
